No solvents or isocyanates, not subject to shrinkage after polymerization it develops high bonding strength, permanent elasticity, excellent moisture resistance and adhesion to substrates.


Accredited for bonding floor composites according to EN 45545-2: 2013 in the railway sector.

# **TYPICAL APPLICATIONS** (professional use)

- MS SPRAY F is indicated for bonding of resilient floor coverings such as marine rubber, linoleum and similars, to various materials, as wood, steel, aluminum, fiberglass, leveling screed (preliminary tests are recommended), as well as
- Particularly suitable for the laying of floors subjected to shock and vibration typical of the means of transport and which must meet the classification of fire reaction HL2 for R10 requirement of NF EN 45545-2:2013.

# **LIMITATIONS**

- Applications in water continuous immersion have to be double checked with Fratelli Zucchini S.p.A. Technical Area.
- Not suitable for joints in swimming pools and adjacent areas that are in continuous contact with pool water.
- It must not be used for items that come in contact with food, or with materials that ooze oily substances or plasticisers.
- Furthermore, it must not be applied in completely enclosed spaces, with no exposure to atmospheric humidity.
- Do not use in extreme temperature conditions, or on damp, frozen, contaminated surfaces.
- Do not use on excessively acidic or basic substrates. Not suitable for use on natural copper.

MS SPRAY F has been classified "Adhesive for floor composites" HL2 for R10 requirement of NF EN 45545-2:2013 with CREPIM reference 2132/01/245.

#### **METHOD OF USE**

Adhesion and surface preparation: surfaces to bond must be dry, clean and free from dust or loose material, oil or grease that may affect the adhesion, floors to be covered have to be flat and levelled enough.

In case of fire retardant wooden planks fixed to a metal frame, typical in the field of transport, provide for an adequate grouting of the hardware and sealing of the joints, sanding if necessary the entire surface to coat (to maintain the fire resistant requirements of the plank use MS TECHNO FR).

In the refurbishment of the flooring, after the removal of the old coating, MS SPRAY F showed excellent adhesion to some polyurethane based leveling substrates used to eliminate irregularities due to residues of the old adhesives.

Considering the different nature of the substrates it is always recommended a preliminary test.

In the case of floor coverings in cementitious screed, moisture levels of the latter will have to be within the recommended values:

- Usually not more than 75% of relative humidity RH or, according to the used method, max 2% of absolute humidity for cementitious screeds, max 0,5% for anhydrite.
- For substrates with embedded heating acceptable levels of humidity for the installation are respectively 1,8% and 0,3%.

With MS SPRAY F is also possible to coat existing ceramic or marble floorings: they have to be well clean, dry and free of grease before applying the adhesive.

Excellent adhesion to metal surfaces which generally must be simply devoid of rust or treated with anti-corrosion protection. Preliminary tests are recommended to check the compatibility and the possible need of PRIMER WP.

On fibreglass it can be enough cleaning with acetone, the best result is obtained sanding and cleaning the dust with acetone before.

Preparation of resilient liner: before installation let to acclimate the coating material to the environment for some hours and relax the internal stresses caused by the packaging; roll out sheets supplied in rolls or at least loosen them.

Adhesive Application: apply the adhesive with a notched trowel getting a such uniform thickness to be covered within 30 minutes at 20°C - 25°C. Minimun doses are recommended for thin sheaths.

After the tooling proceed to the coating installation within 30', and in any case before the skin formation and to perform rolling for adhesive bonding at its best and to release any air bubbles out from under it.

Once completed the rolling, put appropriate wooden planks on the floor to pass without marking the surface since the adhesive is still wet.

Place some weights in order to exert the necessary pressure.

It is recommended to operate in environment temperatures above +5°C.

The final result will be after 24 - 48 hours.

Solvent wiping: traces of MS SPRAY F can be cleaned using SOLVENTE ST 512.

Cured product can be removed mechanically.

Paintability: it should be kept in mind that any overpainting can modify the surface elastic properties of the sealant and its ability to flex with movement and may compromise the functionality of the joint.

The compatibility of the sealant with the paint must first be verified by testing.

Aesthetically pleasing results can generally be achieved by applying the paint after the sealant has hardened completely.

# STORAGE STABILITY

- 290 ml. cartridge 18 months from the date of manufacture.
- 600 ml sausage 18 months from the date of manufacture.
- 5 kg pail 12 months from the date of manufacture.
- 25 kg drum 12 months from the date of manufacture.

Store the sealed product in the original packaging, in a dry place at a temperature between +5°C and +25°C. The product may become more viscose during storage.
